ST. LAWRENCE RIVER ESCAPE

Clayton, NY

Thursday & Friday, May 27 & 28, 2021

Do you need a break and an escape from four walls? Join us for a relaxing overnight getaway to the River and the beautiful 1000 Islands Harbor Hotel. Safety precautions are in place, and masks are required while on the bus. If you're ready to go, we've got you!

Thursday, May 27

9:00am Depart Rome – Freedom Plaza, 205 Erie Blvd

9:30am Depart Utica – In front of parking garage next to Delta Hotel

At **Tug Hill Vineyards** enjoy beautiful views of the Black River Valley from this farm winery/distillery. Our visit includes a **guided tour, wine tasting, and lunch**. As we continue our journey, we'll make a brief photo stop at the scenic **Tibbetts Point Lighthouse** in Cape Vincent, "where lake and river meet". The lighthouse was built in 1827 and overlooks Lake Ontario and the St. Lawrence River.

This afternoon check in to the luxurious AAA Four Diamond **1000 Island Harbor Hotel**, located on the shore of the St. Lawrence River. Beautiful grounds, evening firepits, and spacious guestrooms (with mini-frig) await. Located within walking distance to shops, restaurants, and museums. There is also an on-site restaurant and bar.

The evening is yours to unwind, relax, and dine at your leisure.

Friday, May 28

Breakfast included at the hotel. This morning there is time to enjoy the river view, go for a stroll, visit local shops, or maybe try a wine tasting at Coyote Moon, purchase cheese at River Rat, or visit a museum on your own. Room check-out is 11am so take your time and enjoy the morning as you choose. (We'll provide you with maps of the village). *Be sure to have lunch or bring it with you before we depart.

This afternoon we visit **Wellesley Island State Park** where the adventurous can walk a trail. Take a **guided tour** of the **Minna Anthony Common Nature Center** and see displays and exhibits.

Approximate return to Utica is 5:30pm, and Rome 6:00pm.
